Concerning certification of gaming devices, the FGB only recognises certificates from bodies that have an accreditation based on the Ordinance on accreditation and designation (OaccD ; CCFL<sup>1</sup> 946.512) or an equivalent foreign accreditation. The certification's object shall match up the accredited field of expertise. Each certificate shall clearly include the reference to the accreditation body.
